APPOINTMENT OF COMMISSION OF ENQUIRY
INTO THE PRACTICAL ASPECTS OF A
CHANGE-OVER TO A DECIMAL COINAGE
SYSTEM.

It is hereby notified for general information that His Excellency the Governor-General has been pleased to appoint a Commission of Enquiry consisting of a Chairman and fourteen members, namely—

Om, met inagneming van die verslae van die Becklakekomitee en die Suid-Afrikaanse Buro vir Standaarde, ondersoek in te stel na en verslag uit te bring oor—

- (1) die desimale munstelsel wat hy, na oorweging van die voor- en nadele van die verskillende moontlike desimale stelsels, as die geskikste vir die Unie beskou;
- (2) die metode waarvolgens die aanbevole stelsel ingevoer moet word ten einde die koste van oorskakeling en die ontwrigting van die ekonomie gedurende die oorgangstydperk sover doenlik te beperk;
- (3) die beraamde koste van vervanging van boekhou- en soortgelyke masjiene, asook ander koste verbonde aan die oorskakeling, in die veronderstelling dat die nuwe stelsel op die aanbevole wyse ingevoer word;
- (4) die mate waarin en die grondslag waarop vergoeding ten opsigte van die koste van oorskakeling deur die Staat betaal moet word, indien die beginsel van vergoeding deur die Regering aanvaar word;
- (5) ander praktiese aspekte van oorskakeling na 'n desimale stelsel wat nie hierbo genoem is nie.

Belanghebbendes wat verlang om vertoe tot boegnoemde Kommissie te rig, word versoek om met die Sekretaris, Kommissie i.s. Desimale Muntestelsel, p/a die S.A. Buro vir Standaarde, Privaatsak 191, Pretoria, in verbinding te tree.

with the following terms of reference:—

To enquire into and report on the following matters, with due regard to the Reports of the Becklake Committee and the South African Bureau of Standards:—

- (1) The decimal coinage system which, after consideration of the advantages and disadvantages of the various possible decimal systems, it regards as the most appropriate for the Union.
- (2) The method by which the recommended system should be introduced in order to limit so far as possible the cost of the change-over and the disruption of the economy during the transition period.
- (3) The estimated cost of replacement of accounting and similar machines, as well as other costs connected with the change-over, on the assumption that the new system is introduced in the manner recommended.
- (4) To what extent and on what basis compensation in respect of the cost of the change-over, should be paid by the State, if the principle of compensation is accepted by the Government.
- (5) Other practical aspects, not mentioned above, of the change-over to a decimal system.
